Your Board of Trustees has been monitoring the COVID situation since it began nearly a year ago. As you may recall, we originally had scheduled our reunion in Columbus, GA for April 2020. When the COVID situation looked like it was going to be running rampant in April, we postponed it until September. Well, as everyone knows, that plan had to be scrapped because the virus was even worse then. With everyone's safety in mind, we decided to shoot for May 2021.

Here we are early 2021 and while there is hope on the horizon with a vaccine in sight, things are starting to look a little more positive. However, the month of May could be just a little too soon for us to attempt to get together safely. I know everyone must be suffering from cabin fever as much as I am and itching to get out of the house. If you have been following the guidelines like we have, I am sure you are already going stir crazy and if not, you soon will be. Hopefully we'll have a better grip on that situation when we mail out the reunion information. There may be a possibility of having rides on a Huey (D-Model) available. We will provide as much information as we have available when the information is sent out.

September, 2021 will probably be much safer to travel and gather together and there may still be some restrictions for us to follow. Whether we still be required to wear face masks, practice social distancing, or if there will be restrictions on serving a buffet of snacks in our hospitality room is unknown at this time, but we'll just roll with the flow.

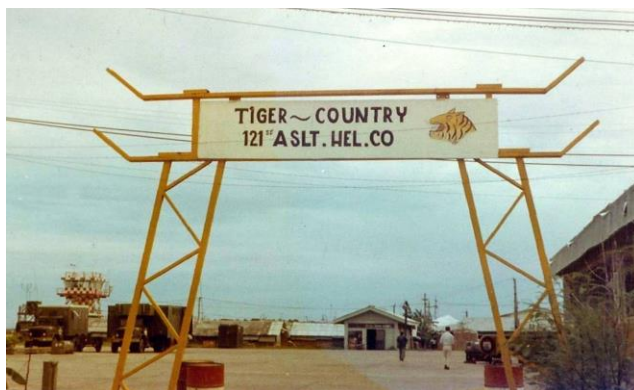
